

1. Jurisdiction of the University

- 1.1. Admission to the seats in the affiliated institution(s) of The West Bengal University of Health Sciences in M. Sc. Applied Nutrition Courses shall be made on the basis of the inter se merit lists of different castes of candidates
- 1.2. M. Sc. Applied Nutrition: On the basis of the results of the West Bengal Post Graduate Applied Nutrition Admission Test Examination (WBPGANAT) to be conducted by the West Bengal University of Health Sciences (WBUHS).

2. Eligibility criteria

2.1. The course is open to the citizens of India who have obtained the degrees of B. Sc. (Hons) in Food & Nutrition / Dietetics / Food Science / Biochemistry / Physiology / Food Technology or B. Sc. in Clinical Nutrition and Dietetics with a minimum of 55% marks in the honours or major subject from any recognized college under a recognized university.

2.2 Candidates passing out in the calendar year of 2009 and 2010 only will be considered for admission.

2.3 Those who have appeared for the final of the aforesaid examinations may also apply, but will have to provide proof of passing the examination (Mark Sheet or Pass Certificate) at the time of counseling.

3. Method of Submission of application

4. Admission test

- 4.1 Admission tests will be conducted by the WBUHS for the candidates seeking admission to the M. Sc. Applied Nutrition Course. Applicants for admission will be provisionally allowed to appear in the Admission test provided they have submitted their applications in the prescribed form as per **Guidelines** for Submission of Application and have fulfilled the eligibility criteria outlined above.
- 4.2 The question papers for the Admission tests shall be set in English and each shall contain 100 single best response type Multiple Choice Questions.
- 4.3 The duration of the Admission test will be of 80 minutes.
 - 4.4 MCQ-s will be set on the following subjects: Physiology; Biochemistry; Nutrition; Community Health: Food Sciences; Maternal and child nutrition..

- 4.5 For every correct response to the MCQ-s 4 (four) marks will be awarded and 1 (one) mark will be deducted for every wrong answer. 1 (one) mark will also be deducted for more than one response to a same question. No mark will be deducted for not answering any question.
- 4.6 Qualifying marks for empanelment for counseling will be a minimum of 140 (One hundred forty only) marks for SC / ST candidates and 160 (one hundred and sixty) marks for others including OBC.

5. Merit list of candidates

- a. The rank of the candidates will be determined on the basis of the marks obtained by them in the admission test descending order marks.
- b. In the event of more than one candidate securing the same mark, the rank shall be determined according to the following principles:
 - i. The relative position of such candidates in the merit list will be determined on the basis of the number of wrong answers, i.e., the candidate giving more wrong answers will be placed in lower position in the merit list.
 - ii. If the ranks of the candidates cannot be determined by application of the above principle, the candidate older by age will be in the higher rank than the candidate younger by age.
- c. There shall be separate list indicating merit position for the SC / ST / OBC candidates.

6. Counseling for selection of candidates for admission

- a. Admission to M. Sc. Applied Nutrition course will be made through personal appearance (counseling) strictly according to the time schedule to be published by WBUHS in its website on production of the counseling fee. For personal appearance the candidates will be called in order of merit.
- b. The provisional merit list as well as the venue, date and time of counseling will be available at the notice-board of WBUHS and its website. No separate information will be sent to individual candidates in this regard.
- c. A candidate will have to appear in person before the selection committee on the date of counseling; otherwise she will be marked absent and her candidature will stand cancelled.
- d. However, in case a candidate is unable to appear in person on the day of counseling, she may send her authorized representative with an Undertaking and Authority Letter for allotment (proforma for Undertaking and Authority Letter are

available in www.thewbuhs.org), along with required original documents and fees. The allotment made to the authorized representative shall be binding on the candidate.

e. The candidate appearing for counseling will have to bring the following original documents along with their attested copies:

Without which they will not be allowed to participate in the counseling

- (i) Admit Card of the Admission Test in original
- (ii) Mark-sheet(s) of qualifying examination & Provisional/Final passing certificate in original
- (iii) Proof of age, e.g., Admit card or Certificate of Madhyamik or equivalent examination
- (iv) SC/ST/OBC certificate, wherever applicable
- (v) Any other relevant document.

7. Reservation of Seats

6.1 A total of 25 (Twenty-five) seats are available for the course.

6.2. Proportion of seats kept reserved for the SC, ST & OBC candidates will be in accordance with the existing Govt, rules. The government order and / or the court directives which will be in force on the respective day of counseling will be followed. Designated point roster will be followed by the University for this purpose.

6.3. Seats reserved for SC candidates when remaining vacant even after following the instructions laid down in the Govt. orders and notifications, shall be filled in by the ST candidates and vice-versa.

- 7. Fee structure for the course:
 - a) Tuition Fee: Rs, 24,000 (Twenty four thousand) per annum (to be paid in not more than two installments)
 - b) Caution money (Refundable): Rs. 10,000 (Ten thousand)
 - c) Admission fee: Rs 2000

8. Other information

- 8.1 Candidates need not submit any supporting document along with their application form.
- 8.2 The allotment of examination centre will be done by WBUHS and will be final and binding.
- 8.3 There is no provision for rechecking/ re-evaluation of the answer sheet (which is one page Optical Mark Recognition (OMR) sheet) and no query in this regard will be entertained.

9. GENERAL RULES AND PROCEDURAL DIRECTIVES

9.1. Applicants should go through and strictly follow the instructions given in the Information Booklet as published in <u>www.thewbuhs.in</u>, while applying for MHM course. Application must be complete in all respect.

9.2. Applicants are required to visit the official Website of the University <u>www.thewbuhs.in</u> for applying on-line. The print-copy of the application along with a crossed **Demand Draft** of Rs. 1000/- (Rupees One Thousand) purchased from any nationalized bank of India, drawn in favour of 'The West Bengal University of Health Sciences' payable at Kolkata. **PRINT-COPIES WILL BE RECEIVED IN THE OFFICE OF THE WBUHS, EITHER IN PERSON OR BY SPEED / REGISTERED POST LATEST BY 08.07.2010. AND 12.07.2010 RESPECTIVELY. THE DEMAND DRAFT IS TO BE PURCHASED ON OR BEFORE 08.07.2010.** Candidates are requested to write their **name and telephone number** on the back of the **Demand Draft**.

9.3. Sponsorship certificates for Government Sponsored candidates are to be submitted during counseling.

9.4. Submission of incorrect or false statements / documents or suppression of material information in the application form will be considered as sufficient ground for cancellation of the candidature or the admission of the candidates to a Master in Hospital Management course whenever detected, i.e. during the process of admission or even at any stage thereafter. Incomplete application forms will be summarily rejected.

9.5. The selection / admission of a candidate shall stand cancelled if he / she is found guilty of copying from any material whatsoever or of taking the help of any electronic media / devices during the examination, or of assisting others or of being assisted by others in any manner whatsoever in writing out the answers during the examination. In this context, decision of the Centre-in-charge and /or the University Observer will be final and binding.

- 9.6. Questions will have Multiple Choices that would be answered through OMR.
- I) The test will be objective in nature and for each question four suggested responses will be given of which ONLY ONE answer will be chosen as the best response.
- II) The Answer Sheet will be machine-scored and therefore requires specific procedure to be followed as given below:

The answers will be marked only by blue/ black ball-pen supplied by the University. No other pen / pencil are allowed.

- III) The method of marking answers is indicated below:
 - Each question will be followed by answers marked as (a), (b), (c) or (d). Select the most appropriate answer. Then, using **blue/ black ball-pen** blacken the circle bearing the correct answer index against the serial number of the question on the answer sheet completely.
 - Please note that the mark should be dark enough and the circle should be filled in as completely as possible. You need not make special efforts to darken any circle artistically.

9.9. The qualified candidates whose names will be published in the Provisional Merit List will have to submit all the attested copies of supporting documents along with **originals** for verification of their eligibility to the course.

9.10. The Merit list will be notified in the notice-board of the WBUHS and will also be available in the website <www.thewbuhs.in>. No communication in this regard will be made to the candidates personally.

9.11. Candidates selected for admission through counseling must obtain the offer letter on the day of counseling on payment of the requisite fees.

9.12. The candidate should report to the head of the Institution within the date mentioned in the offer letter.

9.13. IF A CANDIDATE DOES NOT REPORT TO THE ALLOTTED INSTITUTION WITHIN THE STIPULATED DATE HIS / HER ADMISSION TO THE COURSE WILL STAND CANCELLED.

9.14. No travel allowance is admissible for appearing in the written examination or for attending counseling.

9.15. No personal communication will be made to the candidates, unless it is considered absolutely necessary by the University authority.

9.16. Admission of candidates belonging to WB Govt. service will be in accordance to the relevant Government orders prevailing at the material time.

Appendix-II

Guidelines for Submission of Application

*1. A candidate seeking admission through WBMAT is required to submit his/ her application **online** by logging in <u>www.thewbuhs.in</u> Application submitted by all other means will be summarily rejected.

*2. The candidate will, first of all, visit the university website <u>www.thewbuhs.in</u> through internet. He is required to go through the relevant '**Information Booklet**' carefully and acquaint himself / herself with all requirements regarding filling in the application form.

*3. In the home page look for the Information booklet at the right hand bottom corner. For on-line submission of forms, click on the specific link under the heading APPLICATION.

*4 The **'Online Application Form'** is to be carefully filled by selecting appropriate options or by typing in Block Letters in appropriate places. Please do not skip any point.

*5. After completing the form the candidate is advised to go back to the top of the page and revise all the details he/she has filled. Only after being fully satisfied, click **'Submit'** at the bottom to go to the next page. If any change is required click "Reset". Once submitted, the entries cannot be changed.

*6. After clicking "Submit", two more pages will appear with serial no. Candidates have to print both the pages as those will have to be submitted to the WBUHS. Please keep photocopies of those pages for your record. Application forms without serial no. and missing data will not be entertained.

*6. After "Submit" the next page will show the details of the entry. A print copy of this page is to be then taken. The candidate's signature and Left Thumb Impression are to be placed on to the space provided in this page. Each candidate can submit only one application form.

*7. The next page will have to be printed and then '<u>Continue to open the last page</u>' at the bottom of the page is to be clicked. The last page also is to be printed. Print-out of these two pages will have to be submitted to the office of the 'Controller of Examinations, West Bengal University of Health Sciences (WBUHS), DD-36, Sector-I, Salt Lake, Kolkata-700064' after:

i) pasting two photographs of the candidate (one must be attested by a gazetted officer or Principal of the college last attended) at appropriate places in the last page,

ii) putting the candidate's signature at appropriate places in the last page. The declaration must be signed (which should be fullname) in the same page of the declaration.

iii) putting left thumb impression in the appropriate place

iv) attaching the bank-draft /bankers' cheque for Rs. 1000/- in favour of 'The West Bengal University of Health Sciences' payable at Kolkata

v) attestation should be by a gazetted officer with legible seal with designation in the certificate vi) attaching an unstamped self-addressed envelop and

vii) mentioning the name of the 'course applied for' over the envelop

8. Once submitted no request for change of any entry will be entertained by the University

*9. All forms submitted after the stipulated last date/ all incomplete or invalid forms will be rejected without any further reference to the candidate and the fees submitted, if any, will be forfeited as processing charges.
